**What knowledge/skills that you learned at UF have helped you work with English language learners?**

Being in Miami-Dade County, a majority of our ELL students work with the bilingual psychologists. It can also be a collaborative effort between a monolingual psych (like myself) and a bilingual psych. I've worked with students in higher levels of ESOL who are fluent in English, and those in lower level ESOL mostly work with the bilingual psychologists. The UFSPPP taught me so much about working with diverse populations and different considerations when working with specific populations. The biggest takeaway for me was that no one will ever be fully culturally competent and there is always room for growth in that area. Staying up to date with PD workshops and seminars, and sharing that knowledge with my schools, are the best ways I can ensure we are doing the best we can to service our diverse student population.

**What did you learn in your program that specifically contributed to your effectiveness this year in increasing student learning/achievement?**

The biggest takeaway here is that there is not a one-size-fits-all approach to increasing student learning and achievement. In order to be an effective psychologist, we must operate on a case-by-case basis in order to ensure the best outcomes for our students. I truly believe that each and every course in the program played a role in contributing to my effectiveness in increasing student achievement. From psychometrics to intervention, there are many avenues to increase student learning.
