- Associate Dean Thomasenia Adams
 - OER Pre- & Post-Award divisions
 - Responsible for several awards reminder for four awards applications are due by April 3rd
 - o Pay attention to upcoming opportunities for other awards
 - o April 14th seminar all things pre- and post-awards everyone is welcome to join
 - o Getting ready for next cycle of tenure and promotion

- Associate Dean Erica McCray
 - Searches continue
 - Related to DEI not sure what is going on CEO meeting tomorrow
 - Community engagement survey number of responses already received and there
 may be some direct requests coming out, as we want to have a more comprehensive
 understanding
 - Global engagement received input from UFIC. Please make sure to reach out to the deans if you are planning on, or are in the process of, doing international work (including inviting faculty). There are several countries that we are unable to make formal arrangements.
 - Tara Mathian working with colleague visiting this week scheduled a Q&A, and people are invited to attend. Please be on the lookout for that, as it will happen this week)
 - o Full bright awareness month
- Associate Dean Tina Smith-Bonahue
 - Admission season Cat Hudson, the admission coordinator, is working with programs and applicants to process applications as efficiently as possible
 - Scott Davis is working as a recruiter, and has reached out to program coordinators to help with yield
 - Scholarship season committee will complete work this week, and are giving away over \$400,000 dollars
 - 30 fewer completed applications as last year
 - However, same number of partial applications as completed last year
 - O Reversal of long-standing policy, graduate school will not extend graduate faculty status for faculty leaving university automatically (e.g., for people who retired, but still have active doctoral students) issues with Florida's retirement systems after retirement, no one is allowed to do partake in university responsibilities for 6 months (including serving on committees) after 6 months, they can apply for an extension and this will be granted on a case-by-case basis
 - This is a blanket policy, so it applies to everyone.
 - When people left UF for other reasons, they could extend graduate faculty status, but not anymore. This has now been rescinded. These individuals will receive a link that will allow them to request an extension. In most cases, those faculty members have been reinstated.
 - New fiscal models being considered for the university -this may challenge some of our assumptions on we staff classes, but is also an opportunity to explore new ways to teach-lots of conversation on professional development.
 - Center of Teaching Excellence Jason Arnold and I will work with school directors to come up with a plan to review course. This will impact faculty that teach online courses in any way.
 - Career connection liaison available for our programs to support our students (e.g., clothes closet to provide students with interview apparel)
 - April 4th COE Research Symposium college event, with heavy consultation from graduate student council
 - o May 6th COE recognition ceremony recognize our graduates students names are called and they have the opportunity to shake the dean's and school director's hand. If

- you are interested in participating, then please let Tina know. They do need a faculty marshal.
- After this semester, some time over the summer, Tina will be stepping done as an Associate Dean. She shared that it has been a tremendous pleasure serving in this role, and that the next person who takes this job will inherit a wonderful staff.

 - o There will be a significant change on how travel will be processed at UF
 - o UF GO | CFO CFO (ufl.edu)
 - o UF GO Toolkit Learn & Grow (ufl.edu)
 - o UGO 100 Training: Introduction to UF GO
 - Goes live on April 3rd
 - You will need to complete this course to be able to travel
 - o UF GO:
 - 1. Initiate Travel Request
 - User must submit
 - 2. Supervisor Approval Required (Travel Request Only)
 - Supervisor will receive an email notification
 - Approval can be delegated
 - 3. Financial Approval
 - UF GO Request ID generated
 - Traveler can book their trip
 - 4. Book Trip
 - Use UF GO booking tool or travel agency to complete reservations (comprehensive includes hotels, planes, etc.)
 - Mimics popular booking platforms
 - 5. Complete Expense Report
 - Upload receipts
 - Add expenses
 - User submits for approval
 - World Travel Service
 - UF's authorized agency for all travel needs
 - Available 24/7
 - Management of unused airline tickets
 - Adheres to UF travel policy
 - Pre-negotiated pricing
 - Traveler Profile
 - Connect to frequent traveler programs
 - Managing Receipts
 - Download UF GO app
 - E-mail picture
 - E-mail e-receipt
 - When opted in, e-receipts are automatically collected and matched (e.g., Marriott, Budget)
 - o If there is a cheaper rate for the hotel through a conference rate, you will be able to do this outside of the program. You will just need to scan in the receipt.
 - O Question What if you travel with family and want to book your entire family at the same time to make sure you get seating together. Can you do this through this

program? Dean Dana was unsure of the answer. May be addressed in their FAQ section?

 - Initial conversations with President Ben Sasse are going very well. President Sasse has expressed highly favorable views of the work being done by the College and PKY
 - o Thanks, Tina, for your excellent work as Associate Dean
 - 14% increase, effective July 1st \$4.9 million Hector is trying to make a case on why we should have special considerations with low IDC rates waiting for the President to see what he wants to do about the budget long-term
