- Clarify how students will receive grade; through supervisors to program coordinator; cooperating teachers observe and provide input but play no role in formal grading
- Example of giving a C, B, or A; expectations and at what level student shows proficiency of issue; tracking activity, use students heavily to self report and show what they are doing, how they are improving in certain areas, etc. using FEAPS
- UCC may wish to have more detailed information on justifying change from S/U to letter grade
